# PSCG Membership Guidelines

Being members of Pine Street Community Gardens (PSCG) means agreeing to the following Guidelines:

## Garden Membership

1. I/We will **pay a non-refundable annual membership fee of \$35**, due March 31st of each year. I/We understand if I/we do not pay the membership fee by the due date, I am/we are giving up the plot and the plot may be reassigned. I/We understand it is my/our responsibility to ensure my/our membership form and fees are received by March 31 of each year regardless of how/if/when I am/we are reminded by the Board.
2. I/We will **be the primary gardener(s) of the plot throughout the garden season**. If I/we will be away for part of the growing season, or if I am/we are unable to garden for any other reason, I/we will find someone to tend to the plot.
3. I/We will **advise the Membership Coordinator by email if I/we cannot keep one or more of the commitments in these Guidelines**, or if I/we choose to terminate garden membership. (Note: membership fees are non-refundable except in case of illness.)
4. I/We will **advise the Membership Coordinator by email of any change of address, email or phone number** so I/we can be contacted regarding work parties or other garden business. I/we understand if I/we do not advise the Membership Coordinator of any changes and cannot be contacted, I/we will lose garden privileges and the plot will be reassigned.

## Plot and Garden Maintenance

5. I/We will **use only organic gardening practices in the plot**. This means I/we will not use any chemical fertilizers or pesticides in the garden.
6. I/We will **have dug over and cleaned the plot for the growing season by May 1st** at the latest and started planting by May 24th.
7. I/We will **keep the garden planted and weeded throughout the growing season**. Garden cuttings and trimmings will not be placed on paths or in common areas but will be recycled in a timely fashion.
8. I/We will **plant/maintain and weed the areas immediately surrounding the plot** including keeping the grass around the plot trimmed.
9. I/We will **maintain the structure of the plot**, repairing or replacing the structure as necessary. I/We will not use treated or other potentially toxic materials in or around the plot. Any trellis supports or greenhouses in excess of 5 feet must be approved by plot neighbours. Plantings will not extend beyond the boundaries of the plot.
10. I/We will **not prune, plant or remove trees** in the plot or within the community garden without Board consent
11. I/We will **“winterize” the plot by November 1st**.

## Community

12. If I/we choose to use the communal compost bins I/we will **not add weeds, diseased plants, rocks, or any non-organic materials (e.g. plastic) in the compost**.
13. I/We will **clean and return tools to the garden sheds after use**.
14. I/We will **participate in a minimum of 3 work parties throughout the growing season, or the equivalent of 6 hours**. If I/we cannot participate in at least 3 work parties, I/we will arrange make-up work with the Board during the growing season (i.e. *before* the last work party). I/We understand it is my/our responsibility to either attend work parties or to arrange make-up work, regardless of how/if/when I/we are reminded by the Board. Work party dates are posted on the web site and in the garden sheds.
14. I/We will **not engage in abusive or disrespectful behaviour** toward any member of the garden or the general public.
